Job Purpose/Role

Key Responsibilities

- As part of an international AIM investment team, conduct legal review of and negotiate legal documentation for alternative investment transactions of the Allianz insurance companies with international counterparties;
- Throughout the implementation of such transactions, advise on all legal matters and align/coordinate within Allianz as well as with external legal advisors;
- Analyse and advise in connection with the development of new investment structures and investment platforms, as well as investment related projects.
